To be implemented:

1. Corporate Members A Corporate Member shall be a Society or Committee devoted to neuroimmunology or cognate discipline, a National or Regional Chapter of the Society, or similar scientific society. Application for Corporate Membership shall be sent to the Secretary/Treasurer and shall be accompanied by a statement of the nature of the scientific society.

Membership will be accepted by majority vote of the Board. Each Corporate Member shall pay an annual subscription to the Society, the amount of which shall be in relation to the number of individual members of the society and in accordance with the fee categories decided by the Board. All individual members of a Corporate Member Organization are entitled to individual membership of the Society.

Corporate Members of the Society will have representatives on the Board of the Society with voting rights.

Corporate Members shall promote among their members knowledge and active interest in the objectives and work of the Society, and shall inform the Secretary-Treasurer of the Society of events and developments in their geographical regions that are of importance to the Society.

3. Supporting Members

Supporting Members shall be commercial companies, foundations or other bodies who wish to contribute financially to the objectives of the Society. Membership will be obtained by invitation from the President or the Secretary-Treasurer and upon recommendation of the Board. A Supporting Member shall be responsible for payment of an annual subscription to the Society, the amount of which will be recommended by the Executive Committee to the Supporting Member. **APPROVED**
